We will be riding every day, we will also be doing the following at some point during the week—grooming, saddling, and bathing the horses. We will be doing barn work, which you know what that means? Yep you guessed it, we have to feed the horses, oh and clean stalls. When we are not riding or at the barn we will either be playing fun games or doing crafts. We are excited to share with you our love and knowledge of horses along with our love and faith in Jesus.

You don't have to buy any Special Clothing; Long Pants for Riding & Shorts for all other Activities. If you don't have boots to wear don't worry about it, tennis shoes or shoes with a small heel for riding is fine. **NO SANDALS OR ANY TYPE OF OPEN TOED SHOE!**

We are requiring that all campers wear helmets this year, they must be the approved riding helmet (**NO BIKE HELMETS**) We will have some helmets, but feel free to bring your own (healthy hygiene)

Wrangler Campers should bring a lunch, something to drink and snacks. **BRING PLENTY OF WATER TO DRINK!**

Rancher Campers & Little Britches only need to bring a snack and drinks.

All Campers must have the ability to follow and execute oral instructions.

Every Camper will receive a Valley Mount Ranch Camp t-shirt.

Parents pick up and drop off will be at the office—all campers must check out with us first before leaving with you. If someone else will be picking them up please let us know. There is no after care this year.

A deposit of **\$175.00** per person per session will reserve your space in the camps. The Balance is due **3 weeks** prior to Camp start date. (**Example your camp is June 7th – the balance is due on or before May 17th**) if balance is not paid by due date you will need to bring cash the first day of camp. Checks or credit card will not be accepted.

Deposits are non-refundable

Once again pictures can be purchased of your child at camp— all pictures will be put on a zip drive, the cost for pictures this year will be \$30.00

All order forms must be in by the first day of camp.

Wrangler Camp * \$425.00 Per Person per session. **Age Group 10 years old and older * Limited to 15 kids per camp.** Monday—Thursday * 8 am to 3 pm * **Drop off is between 7:45—8 am** please do not come earlier than this. There will be 3 weeks to choose from—**June 7-10 * July 18-21 * July 25-28** Please make sure to put sunscreen on before dropping child off, pack extra sunscreen incase they need it.

Rancher Camp * \$350.00 Per Person per session. **Age Group 7 to 12 years of age * Limited to 10 kids per camp per session.** Monday – Thursday * There are 2 weeks to choose from—**June 13-16 (8 am to 12 pm)** or **July 11-14 (11:30 am to 3:30 pm).** **Drop off for this camp is 10 minutes before camps start time.** Please do not come earlier than that. Please make sure to put sunscreen on before dropping child off.

Little Britches Camp * \$250.00 Per Person per session. **Age Group 3 to 6 years of age * Limited to 8 kids per camp per session.** Monday—Thursday * There are 2 weeks to choose from—**June 13-16 (12:30 to 3:30 pm)** or **July 11-14 (8 am to 11 am).** **Drop off for this camp is 10 minutes before camps start time.** Please do not come earlier than that. Please make sure to put sunscreen on before dropping child off.

WHEREAS, Rider has agreed to lease riding equipment and horses from Valley Mount for Summer Camp participant, in consideration of certain sums of money to be paid by Rider/Participant. Rider/Participant hereby represents that they have provided accurate information about my riding abilities and experience, and I have advised Valley Mount's employees and agents of any physical impairments that may affect my ability to ride a horse.

NOW THEREFORE, in consideration of the foregoing, the sums of money to be paid by Rider and the riding equipment and horses to be leased for the summer camp to be engaged in, the parties agree as follows:

1. Valley Mount agrees to lease riding equipment and horse to Rider and Rider agrees to lease riding equipment and horses from Valley Mount at Valley Mount's listed price schedule which prices may change without notice. Rider agrees not to permit any person not a part to this Agreement to use said riding equipment or horses.

2. Rider/Participant acknowledges that they are aware that horses are unpredictable by nature; that when frightened or angry or under stress, a horse may jump or run or gallop, kick, buck, rear up in front, or bite and horses are extremely powerful. If a rider falls to the ground, the fall distance will be generally from 3. to 5 or more feet and injury, including permanent paralysis or death may result. I acknowledge that I understand these risks and I voluntarily assume these risks and dangers.

3. That parent or guardian and student understands that upon mounting the horse and taking up the reins the rider is in primary control of the horse and that THIS STABLE is not responsible for the results of the student's actions or inactions. The student further agrees to not abuse, misuse or deliberately agitate the horse as these actions may result in increased risk to them and others.

4. That I have been advised that students should purchase and wear a helmet or hard hat and to wear it in and around THE STABLE so as to reduce the likelihood of horse related head injuries.

RELEASE OF CLAIMS FOR FUTURE DAMAGES AND INJURIES TO PARTICIPANTS INCLUDING MINORS

5. LIABILITY RELEASE: This agreement constitutes a legal release all claims that I or my participating minor child or minor ward in my legal care has against Valley Mount its employees, agents, successors, assigns, officers and directors. Read carefully. I understand that, except in the event of Valley Mount or any of their agents and employee's wanton and willful negligence, that I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH, that may be sustained by me, or my child/ charge or ward in my legal care WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES or otherwise. I specifically release and hold harmless Valley Mount, its employees, agents, successors, assigns, officers and directors for any damages or injuries or death or property damage to me or my child or legal ward for Valley Mount or its employees, agents, successors, assigns, officers and directors or its own negligence and failure to use that degree of care that an ordinarily careful and prudent person would use under the same or similar circumstances. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS Valley Mount or its employees, agents, successors, assigns, officers and directors from any loss, liability, damage or costs, including court costs and all reasonable attorney's fees, that may incur due to my participation in said equine activity, WHETHER CAUSED BY NEGLIGENCE OF Valley Mount or its employees, agents, successors, assigns, officers and directors or otherwise. It is my express intent that this Release and Hold Harmless Agreement shall bind the members of my family, spouse and wrongful death beneficiaries, and personal representatives.
